



### Fitting the Brush/Pad Turn on Water


450mm Brush or 400mm Pad. Featuring the Nulock brush system.


The brush is pushed and twisted to lock, making fitting and removal a simple process. Slide the brush / pad under the brush deck.


Fit the brush / pad onto the Nulock drive chuck, twist to lock the brush / pad in place.

Safety gloves are recommended for the changing of used brushes.

Turn on the clean water tap.









### **Fitting the Floor Tool**

The floor tool has been designed for quick fitting, allowing easy squeegee blade replacement and a safety knock-off feature if the floor tool gets snagged, whilst in transit.

Note: It is easier to fit the floor tool if the weight of the machine is resting on the brush. Ensure the brush is fitted first.







Push waste collection pipe onto the floor tool; ensure a tight fit.


Note: DO NOT push the vacuum hose onto the floor tool with the floor tool in the raised position.


Raise the floor tool for transit or lower for cleaning operation using the lifting handle fitted to the back of the machine.


### Fitting the Hose Guide

The vacuum hose has a U-bend clip which creates a U-bend in the hose preventing water spillage when the vacuum is switched off. If you need to remove the U-bend clip for any reason always ensure it is refitted correctly before you resume operation.













Note: DO NOT push the vacuum hose onto the floor tool with the floor tool in the raised position.

Filling the Clean Water Tank









To fill the clean-water tank, use the FLEXI - FILL pipe from either a tap or hose pipe. (Fig.A & B).

The large cap can also be used for filling from a bucket or suitable container. (Fig.C). Fill the clean-water tank to MAX line indication on tank, including cleaning chemicals if required. Follow chemical manufacturing guide lines.

The clear dump hose at the rear of the machine can be used to see the level of the clean-water. (Fig.D).

Note: Great care must be taken to ensure that contaminants (leaves, hair, dirt, etc.) are not allowed to enter the clean water tank during the filling process. If using a bucket or similar, ensure it is always clean and free from debris.


Control of Substances Hazardous to Health (COSHH)

For best results use a non-foaming type of chemical recommended for use in auto scrubber dryers, dilute to the manufacturers specification. For further guidance on hazardous substances refer to health and safety instructions online.









### **Handle Height Adjustment**

Before performing the cleaning operation, place out appropriate warning signs and sweep or dust-mop the floor.




Open the battery door (A). Make sure Battery locks are open (B) and insert both fully charged batteries (C). Secure the batteries into the machine using the battery locks (D) before closing the battery door














### Raising/Lowering the Floor Tool


After preparing the floor (see page 7), we are now ready to set the controls to suit the cleaning conditions.

Before any settings can be applied, ensure the brush deck is lowered. Move the floor tool lever to its lower position.

Note: Do not pull the machine backwards with the floor tool in the lowered position, this could possibly damage the blades.










Raising/Lowering the Brush Deck

To tip the deck into the down position (Operating mode). Press in the brush deck locking pin (Fig.A)


and rotate the brush deck (Fig.B & C). To change to brush deck up position, (Transit mode) simply lift the deck and the spring loaded locking pin will activate to hold the deck up.











To check the battery level pull one of the Triggers or press button (A).


To start the brush with the configured water and vacuum settings pull either trigger and press the Start switch (A).



The running state of the vacuum (D) and water (C) can be adjusted whilst the brushes are running.

To cancel vac overrun press any switch (vac/water/handle/start)

**System Error Indicators** 



In the event of a fault the battery lights (F) will flash and the unit will stop operating.

The lights will flash a number of times then pause.

The number of flashes can be used to identify the fault.

The errors are split into two groups, low and high priority. Low priority errors are to be expected in normal operation and are represented by the left-hand battery light flashing.

High priority errors indicate something more serious has happened and are represented by all six battery lights flashing. In normal operation the battery display will show the state of charge of the battery with the least charge, there is no indication which battery this is.

The error display can indicate battery related errors, there is no indication which battery has the fault.







To obtain the best out of your TTB.3045.NX Numatic have supplied a 'Deck Pressure Weight' allowing the operator to add or remove pressure on the brush or pad for optimum performance on all floor types.

Remove the Top (Waste Water) tank (1). Set in the lower tank are location pillars (2) to locate the Deck Pressure Weights (5).







TTB.3045.NX comes with one11kg weight (3). Place the Deck Pressure Weight into the machine before using (4). For lightly soiled floors one 11kg weight would suffice, for heavily soiled areas the TTB.3045.NX has been designed to use extra weight if needed (available as an optional extra).




The floor tool design incorporates a break-away feature.

Allowing it to safely disengage from its mounting should it become caught on an obstruction, during forward machine movement.

**Break-away Floor Tool** 

To re-attach the blade to its holder. First loosen the retaining knobs on the floor tool body and slide onto the holding bracket. Tighten retaining knobs to finger tight.

### ALWAYS ENSURE THAT THE FLOOR IS PRE-SWEPT AND RELEVANT SAFETY SIGNS ARE DISPLAYED.



To operate, set water flow rate tap, lower brush deck, lower the floor tool, press the vacuum / water switches, pull brush On/Off trigger.


The waste water is then retrieved by the suction floor tool. Overlap each scrubbing path by 10cm to ensure an even clean. Do not operate the machine on inclines that exceed (2%), when full.

On heavily soiled floors use a 'double scrub' technique.


First pre-scrub the floor with the floor tool in the raised position, allow the chemical time to work then scrub the area a second time with the floor tool lowered.


If streaking occurs wipe floor tool blades clean.

Note: Care must be taken to reduce speed when cornering or when manoeuvring around obstacles





### **ALWAYS ENSURE THAT THE** MACHINE IS SWITCHED OFF PRIOR TO ANY MAINTENANCE REMOVE **BOTH BATTERIES PRIOR** TO ANY MAINTENANCE OPERATION.





Next empty clean water tank, using emptying hose and again flush out with clean water.





Whilst pressing in the top tank separator toggles, remove the separator. (Fig.1) The separator also has a sealing-rubber which should be examined at every clean-down.

Rinse using clean water, avoiding the vac

Remove the filter fitted into the separator and flush with clean-water (Fig.2)





Remove vac filter and clean if required (keep dry).


Never use the machine without the recommended filter as it may cause damage to the machine.


Remove debris basket filter and rinse using clean water, and refit. (Fig.3) IMPORTANT If the debris basket is allowed to become clogged, vacuum performance can deteriorate.

Located under the left hand side is a clean water filter, make sure the clean water tank is empty before removing this filter. (Fig.4) Note: To make access easier, raise the brush deck.










# **Changing the Floor Tool Blades**



Always ensure that the machine is switched off prior to maintenance.





To clean the floor tool, remove securing-pin and pull-free from the holder.


Rinse the floor tool assembly with clean water and refit.


Periodically the floor tool blades should be examined and checked for wear and damage.


The blade removal is easy. Simply start by removing the four retaining pins, turn the floor tool over and separate the blade carrier from the body.


Peel away the blades from their locating lugs and examine or renew as required.

Replacement is a reversal of the removal process.










### Floor Tool Overview

- 5. Floor tool main body





### **Daily**

Keep the machine clean.

Ensure brushes/ pads/ squeegee/ filters are in good condition.

Check for any worn or damaged parts and replace immediately.

Drain and rinse dirty water tank after every use.

Store machine with brush deck secured in tilted position.

### Weekly - as daily and -

Check brush or pad and skirt and rinse.

Check floor tool blades for wear and wipe clean.

Clean separator assembly including filter and check condition of seal.

Flush out system with clean water and clean filters.

#### **Batteries**

Always re-charge the batteries after use.





### 1. DEFECTIVE BATTERIES

- If a customer wishes to return a battery to a supplier, then collection of the battery must be arranged by the supplier; however, Faulty batteries must not be returned through the postal system or by courier.
- 2. If on return to a supplier, OR at a customer base, a suspected defective battery shows any signs of impact damage, distortion, blistering, loose parts, liquid ingress or leakage then on no account should it be offered for condition checking. It must be considered defective and the procedures described from item 9 below should be followed.
- If, on return to a supplier, OR at a customer base, a suspected defective battery, that shows No signs of impact damage, distortion, blistering, loose parts, liquid ingress or leakage, may be offered for condition checking with an appropriate battery condition checking device operated by a competent person.
- 4. If battery is subjected to any liquid ingress users should put the pack upright immediately, with the terminal face downwards.
- 5. If checking shows the battery to be defective then the procedures described from item 9 below should be followed.
- 6. If on checking the battery is found to be operational then a single recharge cycle under observation can be attempted with the appropriate Numatic charger.
- 7. If the battery recharges correctly on this single recharge cycle then it can be deemed a good battery.
- 8. If the battery fails to recharge correctly on this single recharge cycle then it must be deemed a defective battery and the procedures described from item 9 below should be followed. On no account must any further attempt to recharge be made. A defective battery should not be stored inside buildings on any account.
- 9. The defective battery should be discharged by placing it in a container of salt water located in a well- ventilated area. This container should contain 25 litres minimum of saline water at a concentration of 15g common salt / litre of water. The container should have a closed locked lid but should not be sealed. The battery should be left fully immersed in the water to a depth of at least 100mm for at least 2 weeks. The water should be disposed of as hazardous waste when the discharge is complete.
- 10. The defective discharged battery can then be stored in a locked battery waste container which should be plastic or plastic lined and placed away from buildings and clearly signed as a defective battery container with appropriate warnings.
- 11. The batteries should then be sent for waste disposal according with your country's waste regulations.

#### 2. HANDLING AND STORAGE

#### DANGER

Improper handling can lead to an explosion or ignite a fire! Store batteries out of reach of children.


- Insert the battery in the appliance only when it is in use.
- Always remove the battery from the appliance for transport and when it is not in use.
- Storage temperature range: -10°C~55°C.
- Temperatures must not exceed 55°C.
- Relative humidity range: 45 to 80%.
- Optimum preservation of functionality: 15°C~25°C.

#### **WARNING:**

- Do not open the battery, disassemble it or allow it to fall from a substantial height.
- Protect the battery against short-circuiting danger of explosion!
- Protect the battery against rain, do not immerse in liquids especially flammable liquids danger of short-circuiting potential risk
  of fire or explosion. Follow defective battery disposal safety procedure. Insure the product is moved away from any combustible
  source.
- Protect the battery against direct sunlight, heat and fire.
- Do not incinerate the battery danger of explosion!
- Do not use defective or deformed batteries.
- Use only original NUMATIC chargers to charge the battery.

#### STORAGE:

- Good batteries should be stored in a protected area away from sources of direct heat and sunlight and should be kept dry.
- The temperature should not exceed 55°C but preferably not be above 25°C to maintain good battery performance.
- Storage area should be of low humidity, non dusty and a non corrosive atmosphere.



- An example of a well protected area with a cage to protect against accidental impact damage and with the batteries stored in a protective container to protect from heat, impact and accidental spillage of liquids.
- Care when handling / moving with forklift trucks or pallet trucks is needed at all times to avoid any physical damage to the batteries.
- If a good battery at any time is mishandled or subjected to any conditions that may damage it, as described in the battery Instruction manual supplied, it must then be considered as defective and procedures followed from Item 1 of this document overleaf.

### 3. HAZARDS IDENTIFICATION

- Electrolyte may escape from damaged batteries. Avoid contact.
- Contact can cause skin irritation, burns and chemical burns.
- If liquid comes into contact with eyes, seek medical attention.
- Avoid inhaling any vapours formed or released caustic.

### 4. FIRST AID MEASURES

### In the event of contact with released electrolyte or electrolyte vapours:

- Eye contact flush eyes for at least 15 minutes with plenty of clean water without rubbing and seek medical attention.
- Skin contact wash affected areas of skin with plenty of water and soap; if irritation persists, seek medical attention.
- Inhalation provide fresh air or administer oxygen immediately and seek medical attention.
- Ingestion if electrolyte has been ingested, seek medical attention immediately.

#### 5. FIRE FIGHTING MEASURES

- In case of fire Keep clear of vapours and gases generated, take wind direction into consideration. If possible without danger, remove batteries from the vicinity of the fire. In principle, cooling or extinguishing with water is possible, but should only be done by trained personnel with sufficiently large quantities of water.
- If the hazard situation is unclear, extinguish only with ABC powder extinguishers (Class D extinguishers for fires involving metals are especially suitable).


